4. Project/Program Description:

Tallahassee Engaged in Meaningful Productivity for Opportunity (TEMPO) program has successfully reached 363 participants, exceeding program goals and out-pacing its National counterpart, RAISE, D.C., by a 2:1 margin. TEMPO is a public safety and economic development outreach initiative to connect disconnected youth with educational and workforce opportunities. Tallahassee is estimated to have approximately 7,000 disconnected youth who are between the ages of 16-24, that are not in school or employed, and are most susceptible to crime as a victim, suspect or perpetrator. The target service population is 1,000.
