The purpose of this funding is to develop a master site plan for the property that has been purchased for the new judicial center. Over the years numerous judicial officials and users have expressed concerns about the current size and lack of safe corridors in the existing courthouse. To address these concerns, the Board approved the purchased 19 acres in the fall of 2017 for the construction of a new judicial center. A design-build team was hired in January 2019 to begin the site and building design of the new facility.
