Training and certification in Logistics, Manufacturing, Computer Numerical Control, Industrial Machinery Mechanics, and Industry 4.0.

Jobless persons, economically disadvantaged persons, at-risk youth, high school students, college/university students, veterans. HCC has more than 44,000 students who would have access to this project.
