4. Project/Program Description:

Florida's Early Childhood Court (ECC) is a therapeutic approach designed to improve outcomes for maltreated children ages 0-3. Children ages 3 and under comprise 36% of the 24,181 children in out-of-home care and are the largest age group of maltreated children being removed from their homes, primarily due to the opioid epidemic. Early adversity stress impedes early brain development which creates serious issues as children grow to adults. The ECC model utilizes a trauma-informed, judge led, multidisciplinary team of clinicians, community coordinators, attorneys, parents, and others. Parents/children receive more intensive services than traditional child welfare clients, including monthly parent/team meetings and judicial hearings, intensive child/parent trauma therapy, frequent visitation, and developmental and family supports. Florida's ECC is based on the national evidence based Safe Baby Court Teams. ECC's are currently operating in 22 jurisdictions around Florida.

Measured thru DCF data base. 2) 85% of children enrolled in ECC who achieved permanency via reunification will not return to care. Measured via DCF data base. 3) 90% of children enrolled in ECC will improve/achieve their developmental milestones by time permanency is reached. Measured via developmental assessments and pediatric records.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

A Corrective Action Plan would be completed with mandatory deadlines. If not achieved, agency would be placed on probation for a specific time period. If not achieved, contract with agency would be terminated.
