This would allow the Department to locate more non-custodial parents using additional data sources such as a nationwide utility and telecommunication databases; right size child support orders based on "ability to pay" by using real-time income from The Work Number, credit reports and nationwide incarceration booking and release data; Collect and enforce more child support orders with nationwide access to property and financial asset data.

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

Providing additional resources to locate assets allows Child Support Agencies to be more effective in collection of delinquent funds. We know that when Child Support agencies invest in proven practices the return on investment is significant and the reliance on government funded welfare programs to support families decreases.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Funds will allow the Department to utilize a real-time, automated employment and income verification service. This unique database delivers a streamlined, secure and timely transfer of information between employers and verifiers. It is the largest central repository of payroll information in the United States. It utilizes unique data sources, such as current billing records and payment history data from within the utility, pay TV and wireless communication sectors, which allows states to locate more non-custodial parents. It also provides real-income with pay detail to better understand variable pay vs. base pay and historical pay history trends to have more insight into ability to pay, a key element in child support enforcement.

c. What are the direct services to be provided to citizens by the appropriations project?

This service will help streamline child support processes and increase productivity utilizing a data hub to: • Locate more non-custodial parents using additional data sources such as a nationwide utility and telecommunication database. • Right size child support orders based on "ability to pay" by using real-time income, credit reports and nationwide incarceration booking and release data. • Collect and enforce more child support orders with nationwide access to property and financial asset data.

d. Who is the target population served by this project? How many individuals are expected to be served?



Those served would be the total number of children in Florida's child support program, which in 2015, was approximately 667,152, as per the Office of Child Support, Administration for Children and Families, US Department of Health and Human Services Annual Report, 2015.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Results from a pilot study in 2011 conducted by Policy Studies Inc. (PSI) indicate that fee-based automated employment and income verification services, like The Work Number, can be cost-effective tool for enabling caseworkers to locate and take enforcement actions for parents who are not paying their child support obligations.
