**1. Title of Project:** Hurricane Michael - Chattahoochee - Building Repairs

**4. Project/Program Description:**

As a result of damages from Hurricane Michael, the City of Chattahoochee experienced significant damages. Although the city has very limited staff, the available work force worked around the clock to restore operations to an acceptable standard in days following the storm. Since that time the system has been stabilized, but much more is still to be completed. A primary factor in the delay of the recovery has been the lack of available funding to make needed repairs and restorations. As a rural, fiscally constrained community, the City of Chattahoochee has limited resources to meet the overwhelming needs that have been identified. This request, if funded, would allow the city to move forward with important infrastructure projects that would ensure the safety and wellbeing of the citizens of the city.
