#### 4. **Project/Program Description**

Community Health Centers of Pinellas (CHCP), in collaboration with the Pinellas County Schools (PCS), proposes to establish a collaborative Telehealth Partnership aiming to expand the school health nursing services to include access to primary care and mental/behavioral health services via a School Telehealth Program. The funding will allow CHCP and PCS to outfit up to 20 public schools in the neediest areas of Pinellas County with telehealth equipment. Consequently, school nursing staff will be able to access medical and mental/behavioral health consulting services from the CHCP healthcare providers. The Telehealth services will be used by school nurses to address and improve the health status of school children. Furthermore, it will reduce the rate of school absenteeism for children and unnecessary work absenteeism for parents and assure access to quality medical care for children by eliminating existing logistical barriers.

#### 11. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

School-based telemedicine aims to improve overall health status of Florida's children, reduce the rate of school absenteeism for children and unnecessary work absenteeism for parents. The utilization of available telemedicine technology allows school nurses to connect with healthcare providers and assure that children are seen for medical or behavioral health issues without having to leave school for an appointment.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

CHCP will purchase telehealth equipment to furnish up to 20 school-based clinics in Pinellas County and organize dedicated telehealth stations at CHCP locations. The telemedicine gear for a school-based clinic must include components necessary to perform a clinical assessment on a child while concurrently maintaining a live consultation with a healthcare provider at one of CHCP's health centers. The standard telemedicine equipment set that CHCP proposes to acquire will include following: • telehealth computer station; • digital stethoscope, to deliver heart and lung sounds; • general examination camera, to visually evaluate patient; • digital otoscope, to conduct ear, nose and throat examination. The telehealth station at the provider's clinic will include a workstation with a dual-monitor, necessary to effectively conduct the visit. All services will be conducted in a HIPAA compliant manner.

#### c. What direct services will be provided to citizens by the appropriation project?

The funding will allow CHCP to provide medical and mental/behavioral health consulting services to students at Pinellas County schools.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

CHCP will purchase equipment necessary for the provision of telehealth services in 20 Pinellas County schools. The target population will include students of public schools with the highest utilization levels of subsidized school lunch program and located in high-distress areas of the county. The services will be offered to all students, regardless of the status of insurance coverage. CHCP expects to serve 600 children for 1,100 medical and behavioral health visits on an annual basis.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The project will benefit children and their parents throughout the entire Pinellas County. The timely access to medical and behavioral-health care will reduce school and work absenteeism and improve the overall health status of the area's children. Furthermore, coordination of medical and behavioral-health services within the framework of a Patient Centered Medical Home service delivery model will improve effectiveness of both types of care. CHCP will monitor all program outcomes, including the number of patients served, type and volume of provided services with the help of a Nationally Certified Electronic Health Records system and following the standards of Uniform Data System reporting required by the Health Resources and Services Administration.
