#### 4. **Project/Program Description**

The Washington Street roadway improvements project consists of improvements to the alignment, intersection safety, sidewalks, landscaping, and drainage. The project also includes the undergrounding of existing overhead utility lines. The improvements are proposed along a 0.35-mile segment of Washington Street from US 1 to Riverside Drive in New Smyrna Beach. This segment of Washington Street is a critically important roadway segment that provides access to and from the beach and a number of other busy commercial districts. Washington Street is currently lacking roadway infrastructure to provide safe travel for drivers, cyclists, and pedestrians. The Washington Street Improvements project will address the deficient infrastructure and serve as a catalyst for economic development in New Smyrna Beach.

### 11. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The Washington Street roadway improvements will achieve the goal of safe transportation for all users, including vehicles, cyclists, and pedestrians. The improvements will also further the goals of economic development, downtown revitalization, and urban beautification.

b. What activities and services will be provided to meet the intended purpose of these funds?

The activities and services consist of the design, permitting, and construction of the proposed roadway improvements along Washington Street from US 1 to Riverside Drive in New Smyrna Beach.

c. What direct services will be provided to citizens by the appropriation project?

Safer vehicular travel through improved intersection design, better signage and striping, improved drainage performance, traffic calming, and improved visibility. Safer pedestrian travel through new sidewalks and pedestrian crossings. Safer bicycle travel through new bike lanes.

d. Who is the target population served by this project? How many individuals are expected to be served?

The current roadway traffic volume is approximately 2,000 vehicles per day. The target population is all roadway users, including a high pedestrian volume in the downtown New Smyrna Beach area. With the development currently in progress in the immediate area, the roadway is expected to serve a minimum of 5,000 users per day at buildout.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The benefits include safer and more efficient travel through downtown New Smyrna Beach and to and from the beach. The outcome will be measured by traffic volume (vehicles, pedestrian, and bicycle) and by the reduction in the accident rate.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

The City of New Smyrna Beach requires bonding (performance and labor/materials) and enforces liquidated damages on all construction projects. Standard contract penalties for the contract with the state are sufficient.
