4. **Project/Program Description**

The Arcadia Rodeo is constructing a new multi-functional facility that will allow for the expansion of current events, attract new events to the area and improve the current \$3.4 million in economic impact. It will also serve as a shelter for displaced animals during natural disasters. The next phase is to construct the executive offices, board room, additional public/handicapped restrooms, contestant hospitality area, and museum dedicated to the Florida Cowboy Heritage and Tradition. These areas directly impact the daily operations of the facility, will enable us to bring in new events and draw in more visitors to DeSoto County. It is our goal to consistently increase the current annual \$3.4 million dollar economic impact.

11. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The funds will assist in completing phase 3 which includes executive offices, board room, additional public/handicapped restrooms, contestant hospitality area, concession upgrades, and the Florida Cowboy Museum. These areas directly impact the daily operations of the facility, will enable us to bring in new events and draw in more visitors to DeSoto County.

b. What activities and services will be provided to meet the intended purpose of these funds?

Rodeo, equestrian events, musical concerts, trade shows and Expos, and various other events will be the result. The Museum will provide a cultural and historical benefit to the school system, community and state. The facility also serves as a safe haven for displaced animals during natural disasters which will greatly compliment the next door Turner Agri-Civic Center which is a shelter and/or FEMA distribution site.

c. What direct services will be provided to citizens by the appropriation project?

The growing number of various events provide many service opportunities to the citizens such as: food/beverage vendors and suppliers, lawn care services, administrative services, printing and advertising services, insurance, fire safety and security services, transportation services, IT services, etc.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population comes from various sources. We have spectators who come from all over the world to attend our rodeos. Our multi-cultural community offers us many opportunities to hold various events. Our growing list of events currently draw in over 100,000 spectators, contestants, and visitors annually. In addition, our events provide fund raising opportunities for local youth organizations such as DeSoto Band Boosters, Boy Scouts, DeSoto County 4H and FFA. We have a successful youth rodeo program that hosts youth from DeSoto, Hardee, Charlotte and Manatee counties.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The facility provides many benefits: it is an economic generator, provides for educational opportunities to various organizations, enrich cultural experience with the Florida Cowboy Museum, and serves as a disaster relief facility. It is our goal to consistently increase the current annual \$3.4 million dollar economic impact on the community. We have used the Policom Corporation to provide statistical data.
