4. Project/Program Description

The Legal Services Clinic of the Puerto Rican Community, Inc., is a stand-alone non-profit organization, (501 (c)(3)), whose primary mission is to offer no cost and/or affordable legal assistance to those impacted by Covid-19. The Clinic's continuing mission is to provide legal services for under served communities who have been peripherally impacted and to provide legal assistance to persons who are pro se but cannot understand or properly prepare the pro se forms in Osceola County. The Orange County Clerk uses the services of the Orange County Bar Association to assist pro se litigants prepare documents such as divorces, child support, etc. Osceola County has no such assistance. We have been providing assistance for the last year. Without funding we cannot undertake this mission for the coming year. Critically important in Osceola County with the heavy Spanish speaking population and no relationship with any legal entity that can translate and prepare legal documents for the public.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The rendering of culturally and linguistically competent legal services to low income families who otherwise would not have access to legal representation. Our ProSe

project operated from the County Clerks office provides a special service, we assist the citizens who can not fill out the forms for actions such as ProSe divorces, adoptions, name changes, and child support.

This allows for more efficient administration of the court dockets as the Judges are looking at well prepared complaints and petitions which reduces the time for the court to attempt to understand the basis of the complaint when drafted by non professionals.

b. What activities and services will be provided to meet the intended purpose of these funds?

Any and all competent legal representation deemed necessary. The ProSe service makes access to the courts available to thousands who cannot have access without assistance.

This program also allows for more efficient administration of the court dockets as the Judges are looking at well prepared complaints and petitions which reduces the time for the courts to attempt to understand the basis of the complaint when drafted by non professionals.

c. What direct services will be provided to citizens by the appropriation project?

Legal representation and guidance. Our attorneys and staff are all bilingual and can assist both the citizen and the clerks, who cannot give legal advice on how to prepare these forms.

We are able to assist, the citizens, the clerks of Osceola county and the courts all at the same time.

Effectively this expenditure is a cost saving measure.

d. Who is the target population served by this project? How many individuals are expected to be served?

Those who have been impacted by Covid-19 and are in need of legal representation, and the under served communities who have been peripherally impacted.

We expect to serve as many as possible.

The number of clients served will be based on available funding.

We will provide assistance in evictions, foreclosure and bankruptcies.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

We have in the past provided clean deliverables in the number of cases and consultations that we can provide with funding available. We can expect to provide in excess of 400 cases which we can process.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

In the past we had a \$500 per case penalty if we fail to meet deliverables.
