4. Project/Program Description

Prior to the COVID-19 pandemic, Ruth Eckerd Hall served 465,400 Floridians through 538 annual events. The K-12 education programs reached over 45,000 students annually. The Hall continues to find creative ways to serve constituents during the pandemic. The comprehensive re-opening plan includes the renovation of an existing outdoor area to serve both as an education space and a gathering place for performances and community use. This multi-use space will allow students and patrons to distance safely, outdoors, while participating in programming. This updated space offers patrons an outdoor option to participate in cultural programming and art education at Ruth Eckerd Hall, in turn, bringing more support and community involvement back to the Hall.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Funds would help finalize completion of the England Family Music Garden. This venue allows for outdoor performances and an education space. As the Hall finds creative ways to serve patrons during the pandemic, the comprehensive reopening plan includes renovation of the outside area by the east side entrance. This space will serve students, performers, and the patrons with educational opportunities, and as a gathering place for performances and community use. This multi-use space will allow students and patrons to distance safely, outside, while participating in Ruth Eckerd Hall programming.

b. What activities and services will be provided to meet the intended purpose of these funds?

By renovating this outdoor area by the east side entrance of Ruth Eckerd Hall, an improved outdoor performance space will be created. Performers in this space will include local talent, students, touring groups, and artists. The Marcia P Hoffman School of the Arts, the education department at the Hall, will utilize this space for student education, including end-of-term class performances, scholarship showcases, private lesson recitals, pre-show performances, summer productions, and a space to feature local artists and community partners. Professional development opportunities will also take place in this new venue, including teacher training, workshops for instructors, and teaching artists from Pinellas County Schools.

c. What direct services will be provided to citizens by the appropriation project?

Cultural enrichment and arts education, including live performances by both local and traveling artists. The Marcia P. Hoffman School of the Arts will utilize this performance space for students of all ages and abilities to learn and improve performing arts abilities and knowledge.

As COVID vaccines are distributed and people begin to attend live events again, there should be an increase in patrons. Through this project, the Hall's goal is to serve more than half the number of patrons served prior to the pandemic.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The expected outcome of this project is that patrons will attend shows at Ruth Eckerd Hall again, as more outdoor performances are scheduled. This, in turn, will offer cultural entertainment to local elderly, adult and young adult patrons. Additionally, this space will be utilized the by Marcia P Hoffman School of the Arts for outdoor education opportunities, which will increase school attendance, for students and educators who feel safer rehearsing and learning outdoors.

Ruth Eckerd Hall would return appropriated funds to the state should the organization be unable to fulfill contractual requirements.
