12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Holistic legal Services and Representation will be provided to Veterans, Victims of Human Trafficking, Victims of Domestic Violence and Children that have been abused, abandoned and neglected. By providing free legal services we are assisting individuals and families regain personal stability, safety, join the work force and become contributing members of our State. The legal services that we provide empower victims, children, veterans in treatment court and other individuals that we represent to seek and maintain employment and/or an education. By empowering the weakest members in the State of Florida, the cumulative result is that we strengthen our State as a whole.

b. What activities and services will be provided to meet the intended purpose of these funds?

We will provide free legal services and representation in various areas of law including: Family Law, Domestic Violence, Juvenile dependency and Landlord Tenant. We will be attending Veterans Treatment Court and G.R.A.C.E. Court weekly (G.R.A.C.E. court is specifically for victims of Human Trafficking) to offer legal representation to all veterans and victims of human trafficking with court proceedings. We will also conduct regular outreach across the State. Additionally, we will hold various CLE seminars to train and mentor volunteer attorneys that will be representing clients pro bono. These funds will help empower the most vulnerable members of our State through legal services so that they can become contributing members of our State.

c. What direct services will be provided to citizens by the appropriation project?

Services will range from full direct court representation across multiple areas of law, to legal services with filling out documents to help the clients proceed pro se, to legal counsel and advice.

d. Who is the target population served by this project? How many individuals are expected to be served?

This program serves Victims of Human Trafficking, Victims of Domestic Violence, Veterans and Children in the Foster Care System. We serve the Elderly, jobless, economically disadvantaged and at-risk-youth. We expect to serve 1500 - 1800 individuals.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

When representing foster children, we request the appropriate support and educational placement, so that the child feels safe, can thrive and have a successful future. Additionally, victims are not provided with free legal services and thus do not usually testify against their perpetrators. By providing victims with legal representation, we are providing them with the support that they need to testify against the aggressor. This testimony aids the prosecution in obtaining convictions and keeps our State safer. By providing free legal services we are also reducing the amount of pro se litigants and increasing judicial economy along with the economic and social costs associated with domestic violence and human trafficking. By providing free legal services we veterans, we are providing support to those who have done so much for our Country and may currently be facing a legal family law or housing issue. Our services empower clients and reduces their future need for government assistance.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

If deliverables are not met, money will be deducted from the total amount due to the agency as detailed in the contract.
