a. What specific purpose or goal will be achieved by the funds requested?

Training for preschool environment to mitigate risk and save lives in emergency situations such as active shooter events. Optional implementation of a local notification system to alert preschools of imminent danger, as is currently done with K-12 schools, closing the existing notification and training gap and keeping ALL of Florida's children safe.

b. What activities and services will be provided to meet the intended purpose of these funds?

Training will be provided through both direct training with early childhood educators, both In person as well as through on line resources, and also utilizing a Train the Trainer program which will enhance program continuity and keep this important information accessible. Collaborative partnerships between law enforcement, Early Learning Coalitions, and From Cradle to College Foundation will be developed for training on an optional notification system.

c. What direct services will be provided to citizens by the appropriation project?

Training on highly relevant topics including planning and preparing for critical incidents and optional notification systems for preschools.

d. Who is the target population served by this project? How many individuals are expected to be served?

Preschool children and preschool staff of legally operating childcare providers In the State of Florida, approximately 873,000 individuals.

The expected benefit of this project is an increased life-saving awareness of current significant dangers and informed options for action that will mitigate risk and save lives.

The outcome of this program will measured by its successful outreach to Florida statewide with training and optional notification systems, significantly enhancing the safety of Florida's youngest children.
