The purpose of the project will be to install a new sewer collection system and new potable water system in Sandy Creek community.

The new system eliminates the need for continued repairs and costs for the City's system.

This system will also allow the Sandy Creek area to be developed to allow more workforce housing.

The activities and services include engineering, which is required to complete the design and permitting.

The appropriation project will provide a new sewer collection system and new water system with fire flow for the residents of the Sandy Creek area.

The residents of the Sandy Creek area, which have 150 family households and approximately 525 residents.

The expected benefit of this project is to replace the old low pressure sewer system with a new combination of gravity and force main sewer system and replace existing small 2" water mains with 6" and 8" mains with fire flow. The existing system has reached its useful life.
