12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Miami Beach was visited by 7.37 million tourists in 2019. Many of these tourists stay in the South Beach area. As businesses in Miami Beach continue their recovery from the COVID-19 pandemic, providing safe and comfortable pedestrian and bicycle facilities has become a key to accelerate the recovery. In general, transit and transportation network companies have seen a decline during the COVID-10 pandemic due to concerns by the public, as such more people are walking or biking. The goal of the project is to implement area-wide improvements to pedestrian and bicycle facilities in already walkable neighborhoods and designate the area as the South Beach Pedestrian Priority Zone.

b. What activities and services will be provided to meet the intended purpose of these funds?

The Flamingo Park Neighborhood in South Beach was identified as a high crash area for pedestrians and bicyclists in the 2045 Miami-Dade Transportation Planning Organization Bicycle Pedestrian Master Plan. The funds will be used in the implementation of high emphasis crosswalks, signalization improvements, new signage, sidewalk replacement, sidewalk widening, ADA ramp improvements, and traffic calming. All the improvements identified in the South Beach Pedestrian Priority Zone study are intended to improve safety and comfort for pedestrians and bicyclists in the area.

c. What direct services will be provided to citizens by the appropriation project?

The services will consist of construction of the crosswalk, signalization, signage, sidewalk, and traffic calming improvements to ensure successful implementation of the South Beach Pedestrian Priority Zone.

d. Who is the target population served by this project? How many individuals are expected to be served?

While the population of South Beach is just over 39,000 permanent residents, the area is visited by over 4 million tourists per year. The area is also visited by local visitors who wish to enjoy the beaches and restaurants in the area which dramatically increases daily population by more than 100%. The project will serve residents, tourists, and daily visitors and will help recovery and economic resilience of businesses in the area.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The project is expected to reduce pedestrian and bicycle crashes while improving pedestrian volumes and economic viability in the area. The city will closely track pedestrian and bicycle crashes, 85th percentile vehicular speed, pedestrian volumes, bicycle volumes, and business revenue. This data will be utilized to generate short and long term benefit/cost analysis for the project.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The current city contracts include termination for convenience and liquidated damages clauses.
