# 4. Project/Program Description

This pilot program project uses a proven consumer off-the-shelf software application, which uses machine learning and AI, as well as a two-person human review process to identify indications of suicide, self-harm, abuse, harassment, and acts of violence that are found within student-issued, school-provided creation and communication tools.

Looking at national data, and holding constant for the same number and group of students, the fall of 2020 and the impact of COVID-19 have indicated a 47% increase in incidents of suicide/self-harm, a 69% increase in incidents involving nudity and sexual content, and a 23% increase in acts of violence. While states have invested in protecting students in the classroom, virtually little to no investment has been made to patrol the digital classroom. This project provides protection and advanced warning in the school-issued digital creation and communication environments by identifying potentially dangerous incidents prior to their occurrence.

#### 12. Program Performance

# a. What specific purpose or goal will be achieved by the funds requested?

The goal of this mental health pilot initiative would be to protect Florida youth from suicide and self-harm. Suicide is the second-leading cause of death in the country for our youth. Nationally, there are over 3,703 suicide attempts by students in grades 9-12 every day (http://prp.jasonfoundation.com/facts/youth-suicide-statistics/). In Florida, the goal is to protect our K-12 students from suicide and self-harm by catching these warning signs as early as possible.

# b. What activities and services will be provided to meet the intended purpose of these funds?

A combination of technology and humans who are reviewing flagged content 24/7/365 within the school-issued student Microsoft and Google environments, the most common technologies used in schools. This multi-level approach allows for machine learning to quickly flag potentially harmful content followed by two layers of human review, alerting school districts to student safety issues in the shortest amount of time possible, which is often minutes.

# c. What direct services will be provided to citizens by the appropriation project?

School districts participating in the pilot will have 24/7/365 analysis and review of student content in school-issued student Google and Microsoft environments in order to protect students, helping districts identify those who are struggling with mental health or are potentially dangerous to themselves or others.

The target population for this initial pilot is the middle schools and high schools in the state of Florida. This pilot program is designed to protect student lives and ensure struggling students receive the necessary mental health support at the earliest warning signs before it's too late.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

# be measured?

The goal of this mental health pilot initiative would be to protect roughly 600,000 of Florida's 2.7 million students. This protection allows for early intervention and intervention with situations of immediate crisis. With the majority of incidents of self-harm and suicide being identified at the middle and high school levels, this pilot would serve the students most in need of intervention. The long-term goal would be to serve and protect all of Florida's students 24/7/365. Nationally, Gaggle flagged over 36,000 incidents of suicide and self-harm in the first four months of the 2020-21 school year, which was up over 80% from the same time frame during the 2019-20 school year.
