4. Project/Program Description

The Community Based post-COVID Acceleration Initiative is a partnership between the School District of Palm Beach County (SDPBC) and the Urban League of Palm Beach County (ULPBC) to re-engage 90 middle school students following the devastating year of the pandemic and its academic stagnation/regression consequences. The ULPBC will administer this model program in Riviera Beach and work with community partners to ensure maximum student engagement. College students will be hired to provide small group instruction (6:1) under the supervision and support of educators. The estimated budget of \$200,000 provides funding for the college students and educators as well as daily meals, weekly field trips and transportation during this six week summer program.

SDPBC received federal assistance in the amount of \$35.1 million from the CARES Act (excludes amount earmarked for charter and private schools). However, SDPBC has spent over \$45 million on COVID-related costs thus far in service of bridging the Digital Divide and reopening brick and mortar campuses (representing a \$10 million shortfall). Expenses related to cleaning, sanitation, and PPE alone total \$16.3 million to-date, with the total cost projected to reach \$29.6 million by year's end.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The Urban League of Palm Beach County with guidance from the Palm Beach County School District will administer a full day M-F summer camp in Riviera Beach designed to creatively and safely engage middle school students in activities to refresh, reiterate and reteach the grade level skills that they did not learn to proficiency levels due to the distance learning situations created by the COVID-19 pandemic. The need for academic acceleration is great following the COVID slide, superimposed on summer slide which was superimposed on the academic achievement gap which disproportionately impacted students in communities demographically like Riviera Beach.

b. What activities and services will be provided to meet the intended purpose of these funds?

College students (15) will be hired to provide small group instruction to middle schoolers (90) under the guidance of certified teachers (5). A strong literacy foundation will provide the framework for support in math, science and social studies. Educational delivery methods found to be engaging by youth will supplement traditional methodologies. These non-traditional methods might include analysis of vocabulary in popular music including synonyms and antonyms, creation of videos by students to teach other students, explicit math vocabulary instruction, weaving local history into World History, Civics and US History instruction, entrepreneurship, and financial literacy.



c. What direct services will be provided to citizens by the appropriation project?

The proposed program will take place M-F between 8:00am - 5:00pm from June 21-July 30, 2021 (6 weeks) in Riviera Beach. This results in 270 hours of program time. Fifteen college students will be hired to provide small group instruction to 90 middle school students at a ratio of 1:6. In addition, five teachers will be hired to provide guidance to the college students and supplement the supervision and instruction of the middle school program participants. Academic acceleration program activities will be supplemented with athletics, recreation (e.g. chess instruction, dance), arts and Friday field trips to sites that support the educational endeavors.

d. Who is the target population served by this project? How many individuals are expected to be served?

The program will accelerate the academic achievement of 90 middle school students from Riviera Beach. In addition, 15 college students will be selected to mentor and provide small group instruction to middle school program participants--this mentorship experience is structured to enrich the lives of those college students who are hired to support this program.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The expected outcome of this project is to creatively and safely engage middle school students in activities to refresh, reiterate and reteach the grade level skills that they did not learn to proficiency levels due to the distance learning situations created by the COVID 19 pandemic. Participating middle school students will have higher academic achievement levels as a result of this program. This outcome will be measured by diagnostics already used by the SDPBC to monitor student academic success.
