a. What specific purpose or goal will be achieved by the funds requested?

Aerial photography for property appraisers in counties with a population greater than 25,000 but less than 50,000 scheduled for aerial flights in 2021-22: Gadsden, Jackson, Levy, Suwannee and Wakulla Counties.

b. What activities and services will be provided to meet the intended purpose of these funds?

The Department of Revenue in conjunction with the property appraisers in Gadsden, Jackson, Levy, Suwannee and Wakulla Counties will be able to obtain aerial photography.

c. What direct services will be provided to citizens by the appropriation project?

Citizens are able to access aerial photography on a statewide basis. Greater accuracy and equity in assessments in the named counties.

d. Who is the target population served by this project? How many individuals are expected to be served?

The targeted populations are: Gadsden County - 45,945; Jackson County - 47,945; Levy County - 40,403; Suwannee County - 44,046, and Wakulla County - 32,321. The total population served would be approximately: 210,660.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The method for measuring level of benefit would be qualitative and reflected in better accuracy of assessments and property identification. Because the aerial photography is oftentimes shared with other local governmental entities, level of benefit would be reflected in 911 programs, emergency management, planning and zoning, and building permits.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Currently set forth in the Department of Revenue's "Standard Contract" with aerial photography vendors including, but not limited to, the section addressing a Corrective Action Plan.
