The HDEC develops, implements, and presents on-line and on-site Holocaust educational outreach and museum programming, features traveling exhibitions, provides a speakers bureau and resources for K-20 students and teachers as well as teacher training that are all compliant with s. 1003.42, F.S., mandating Holocaust Education: "The history of the Holocaust (1933 -1945), the systematic, planned annihilation of European Jews and other groups by Nazi Germany, a watershed event in the history of humanity, to be taught in a manner that leads to an investigation of human behavior, an understanding of the ramifications of prejudice, racism, and stereotyping, and an examination of what it means to be a responsible and respectful person, for the purposes of encouraging tolerance of diversity in a pluralistic society and for nurturing and protecting democratic values and institutions."

The activities and services that will be provided include: Student Awareness Days which are prejudice reduction and anti-bullying programs; museum school tours to include the HDEC's authenticated Holocaust rail car and U.S. M-4A3E8 Sherman Tank; speakers bureau; the Annual Visual Arts and Writing Contest and "A Simple Act of Kindness" Contest; Meet the Author Series; traveling exhibitions; and teacher training. In addition, the creation and production of two separate Holocaust "resource and reference" USB bands. One for students and another for teachers as well as a Teacher Kristallnacht Guide.

**c. What direct services will be provided to citizens by the appropriation project?**

The HDEC offers a variety of programs to perpetuate the history and lessons of the Holocaust. One of these programs is the traveling exhibitions. In 2019, in honor of our South Florida Holocaust survivors, the HDEC presented the traveling exhibition "Israel Then & Now." Lectures, films, panels, and programs were held to accompany the exhibition including a multitude of Zoom presentations such as "From Darkness to Light" with the Consulate of Israel in Miami. Through these programs, citizens gain a better insight in the evils of hatred, prejudice, racism, and bullying. They also learn what it means to be a responsible, respectful, and empathetic person who will stand up and speak out and be an up-stander in the face of adversity, not a bystander. These programs also teach citizens that words matter and that what they do matters and what they don't do also matters.

**d. Who is the target population served by this project? How many individuals are expected to be served?**

The HDEC programs are targeted to all students K-20 in private, public, and parochial schools as well as colleges and universities. Through these times of COVID the Speakers Bureau offers Zoom Classes with Holocaust survivors and liberators. Student Awareness days have also moved online either through Zoom, Microsoft Teams, and Google Meets. This program gives students a unique opportunity to interact with a Holocaust survivor for a full day which brings history to life for them and they learn first hand from this 20th century hero, what prejudice and hatred can result in if left unchecked. In addition, onsite tours of the museum and authenticated, identified Holocaust railcar and U.S. M-4A3E8 Sherman Tank are also offered. Through these programs and opportunities students learn that no one is immune to hatred, bullying, and injustice. Last year over 25,500 individuals were served and is expected to increase that to over 30,000.

**e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?**

Being a part of an ethnically diversified community in South Florida, the HDEC promotes the ideals of equality, justice, and acceptance of all, no matter race, religion, gender, creed, age, sexual orientation, etc. To that end, the programs center around prejudice-reduction, and anti-bullying, appreciation of all people, and above all that each life is worthy of life. All participants are educated on what can happen if prejudice and violence are left unchecked and to ensure that what happened to the beloved survivors, never happens to anyone, anywhere, anytime, or any place. These programs resonate with students of all backgrounds. Some of the most frequent comments received are that students now appreciate what they have more than ever before and wish to make a difference in their communities to ensure that NEVER AGAIN really does mean NEVER AGAIN.
