12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The purpose of the funding is to be used to renovate the building which will be the first AmSkills Workforce Training Innovation Center in the Tampa Bay Region and to secure additional matching funds from private community donors. The goal is to stir redevelopment opportunities within the Holiday community, a low-income community, and to provide hands-on career discovery training opportunities and apprenticeships for the manufacturing and construction industries.

b. What activities and services will be provided to meet the intended purpose of these funds?

AmSkills was created as an economic development initiative by Pasco, Pinellas, and Hernando Counties to address workforce skills shortages for the manufacturing industry. AmSkills provides "hands-on" skills training for youth and adults; and assists manufacturers to establish apprenticeships. AmSkills focuses on three key areas, RECRUIT – TRAIN – SUSTAIN, providing programs in high schools, traveling to economically disadvantaged neighborhoods using AmSkills mobile workshop to conduct training bootcamps, and providing training programs, apprenticeships, and coaching. AmSkills will be expanding into construction trades.

c. What direct services will be provided to citizens by the appropriation project?

Recruitment, utilizing the AmSkills mobile workshop and creating a production area to replicate the AmSkills bootcamp in other communities; training programs for youth and adults to include machining, mechatronics, robotics, virtual reality, welding, electrical, plumbing, commercial air conditioning, carpentry, concrete, and other manufacturing and construction trade programs. Apprenticeship related training instruction programs will also be provided. AmSkills intends to create a Workforce Training District by creating a non-profit business incubator to provide support services to those in need of the community.

d. Who is the target population served by this project? How many individuals are expected to be served?

Middle and high school students, unemployed, underemployed, persons who lost their job due to COVID-19, economically disadvantaged, at-risk youth, homeless, developmentally disabled, physically disabled, formerly incarcerated, and minorities. Numerous new programs will be created to expand and offer a greater number of individuals workforce training and apprenticeship opportunities in the manufacturing and construction industries. AmSkills is expected to serve more than 800 individuals from within the community.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

AmSkills will continue and expand on the current successful programs for youth and adults including recruitment, training, and apprenticeships for the Tampa Bay region. AmSkills will be expanding from manufacturing into construction and related industry trades. AmSkills is expected to be a catalyst for redevelopment in a low-income community. AmSkills will track the number of participants, the number of participating employers, and the number of participants that secure jobs and local economic impact.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

AmSkills does not anticipate failing to meet any deliverables or performance measures. In the event AmSkills is unable to meet a specific deliverable, AmSkills would communicate reasons and negotiate an extension or an appropriate deduction.
