The public safety radio microwave system serves over 350,000 Lake County residents, including 13 municipal public safety entities, The Villages Public Safety, all medical transport units, more than 1,800 law enforcement officers, numerous state agencies and other necessary emergency first responders and visitors to Lake County. Replacing the system is necessary to enable future system upgrades.
