4. Project/Program Description

To construct a 4,000 sq. foot agricultural training/conference center building, walkway overhang and restroom facilities located adjacent to the Hardee County Agri-Civic Center (which serves as the local hub for much of the agricultural education, Fair Association, schools, civic and community events) and the county extension/University of Florida/IFAS that will accommodate up to 200 people. The training/conference center will have the capability to be sectioned into 2 separate rooms that would accommodate 80-100 on each side. The facility would offer a size variety based on needs of the conference or training being offered, whether the needs require 200 people, or 100 or less. Hardee County is designated as a Rural Area of Economic Opportunity.

Purpose is to design and construct a 4,000 sq.ft. agricultural educational training conference center, walkway overhang and ADA compliant restroom facilities to meet the demand for a facility that will accommodate up to 200 persons to hold affordable, educational/training programs/ seminars & events, providing employment opportunities, increase of tourism & revenues.

Contractual architectural/engineering for final design and a set of construction plans, permitting, bidding, project management and construction of the approved design (4,000 sq.ft. agricultural educational training conference center, walkway overhang and ADA compliant restroom facilities) to meet the demand for a facility that will accommodate up to 200 persons.

c. What direct services will be provided to citizens by the appropriation project?

Once completed, the conference center provides the opportunity to host affordable educational/training programs/seminars to be attended by interested parties, i.e., students, elderly, special needs, residents, visitors, and the business community from the county, surrounding communities and out of state visitors.

Monitoring of event bookings and attendees. Employment maintained from project.
