4. Project/Program Description

Gadsden County has been designated as a Strike Force Zone. Persistent poverty has historically plagued this county. The county is the only predominately African-American county in the state. A food kitchen located in the Stevens School will support a healthy food movement that will address the health disparities of the county, declined income of local farmers, and dwindling number of professional farmers and develop skills and provide support for small businesses. The implementation of the business incubator itself will strengthen the planning, marketing, and management infrastructure of existing farmers and create opportunities for citizens especially young citizens unable to find work. The incubator will be a direct-link to limited-resource farmers with low-income consumers, improve the local economy with the creation of jobs, and increase tax revenue.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The incubator will be a direct-link to limited-resource farmers with low-income consumers. The incubator will improve the local economy by creating jobs and increasing tax revenue. Small businesses will have an increased probability of success. Start-up businesses in an incubator environment have an almost 90% chance of increased success after five years. New ideas and business ventures are sure to flourish in incubator environments. The shelter will be used during emergency evacuations and non-emergency situations as a COVID-19 vaccination and testing site. It will also serve as an emergency response training center for law enforcement, emergency responders from throughout the state, and members of Florida's 67 counties workforce when not used during a state of emergency. The shelter will be located eight (8) miles off I-10, Exit 181.

b. What activities and services will be provided to meet the intended purpose of these funds?

Emerging businesses is a priority for Gadsden County for growing small businesses. The county is committed to expanding small businesses and new start-ups by establishing a revolving loan fund. There are two objectives for the revolving loan fund: provide a revolving financial resource of \$500-\$2,000 for start-up businesses and assist existing businesses by connecting them to larger loan funds with Access Florida, banking institutions, and other financial companies. The program will also help small businesses, especially start-ups, develop business plans, and pay attention to their credit. Management workshops will be held to ensure that the participants will understand the legal and managerial areas. Depot Exchange - A fresh fruit and vegetable Depot Exchange will be developed and will coordinate with all the seasonal local farmer's markets, including the Gadsden County Extension Farmers Market and the Tallahassee Farmers market and others from the North Florida-South Georgia area.

c. What direct services will be provided to citizens by the appropriation project?



Food will be produced to address the lack of quality fruit and vegetables. A community garden will be accessible. A emergency shelter will be constructed. Local farmers and small businesses will benefit from the incubator environment and be armed with the tools and resources to gain market share.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is Gadsden County, 45,000 people.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The Center for Economic Empowerment will address local farmers' declined income and the dwindling number of professional farmers and will develop skills and provide support for small businesses. The shelter will be used during emergency evacuations and non-emergency situations as a COVID-19 vaccination and testing site. It will also serve as an emergency response training center for law enforcement, emergency responders from throughout the state and members of Florida's 67 counties workforce when not used during a state of emergency. The shelter will be located eight miles off I-10 Exit 181.
