12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

To improve the safety, security, and environmental conditions of the courthouse and courtrooms for the employees and officials whose offices and courtrooms are located in the facility as well as the many citizens who access the Courthouse for services and assistance. The generator system will enable the facility to remain functional in the event of an outage and ensure accessibility to all employees and citizens who may need access in the event of an outage.

b. What activities and services will be provided to meet the intended purpose of these funds?

Renovation and improvements will include: security upgrades, elevator repairs and improvements, mold study and the remediation thereof if so needed, and installation of a generator system.

c. What direct services will be provided to citizens by the appropriation project?

A secure and accessible facility with the necessary improvements and equipment to provide a safe and healthy environment. The elevators are frequently in need of repair and often may be closed for several days. The improvements including the generator will ensure all citizens can access the courthouse offices and services. When the elevators are not operational, many citizens with physical disabilities have limited access to services. The mold remediation will provide a healthier facility for employees as well as the many citizens who visit the facility.

d. Who is the target population served by this project? How many individuals are expected to be served?

All citizens who visit the courthouse will be served by this funding e proposed project as well as the employees and those within the court system. More than 125,000 individuals will be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?



The improvements are a necessity to provide a safe, secure, and accessible facility. The Courthouse was constructed in 1969 and as a fiscally constrained county, limited improvements have been made. Current security measures are outdated and do not meet todays standards for a secure facility. The elevators are outdated and in frequent need of repairs. It is suspected the courthouse has mold issues and remediation will be required. The proposed improvements will provide for a safe, healthy, secure facility as well as for the continuity of operations.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

All performance measures and deliverables will be completed within contract timelines and requirements.
