Yes. The entity received \$179,936.75 in Payroll Protections Program (PPP)/Economic Injury Disaster Loan (EIDL) funds through the Small Business Administration (SBA). These funds were used to maintain personnel during the safer-at-home orders and during months where the state's funds had been exhausted. An SBA loan in the amount of \$150,000 was also attained to aid in ongoing cash flow of operations.

a. What specific purpose or goal will be achieved by the funds requested?

R4W-H supports the State of Florida's strategies to reduce incarceration costs, and to reduce Florida's prison population in order to sustain cost reductions. R4W-H's goal is to generate returns on investment not only by reducing recidivism, but also by reducing crime, and breaking cycles of hopelessness. R4W-H's approach through comprehensive reentry services and employment reduces crime, provides job and economic development, and helps to foster self-sufficient members to society.

b. What activities and services will be provided to meet the intended purpose of these funds?

Per existing proviso, these funds will provide a pre-release needs assessment, a plan-of-care, and referrals for incarcerated participants. Ready4Work-Hillsborough will primarily provide post-release services including transitional housing, case management, career development and essential life skills training, life-coaching, family reunification/support, and job placement assistance.

c. What direct services will be provided to citizens by the appropriation project?

Per existing proviso, these funds will provide a pre-release needs assessment, a plan-of-care, and referrals for incarcerated participants. Ready4Work-Hillsborough will primarily provide post-release services including transitional housing, case management, career development and essential life skills training, life-coaching, family reunification/support, and job placement assistance.

Funds will also provide funding for basic computer literacy training which provides essential skills that are critical in today's society and workplace.

d. Who is the target population served by this project? How many individuals are expected to be served?



Offenders under Department of Corrections' community supervision and formerly incarcerated inmates (no more than three (3) years post-release) returning to Hillsborough, Pinellas, Pasco, or Polk counties. We expect to serve 100-150 people.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

1) Improve physical & mental health - Participants will attain pubic healthcare coverage or through their employer; and receive a mental health assessment.

2) Reduce Substance Abuse - Participant will receive a substance abuse assessment.

3) Protect the general public from harm, divert from criminal/juvenile justice system, & reduce recidivism - Formerly incarcerated citizens that are engaged, employed, and empowered are less likely to commit crimes and return to prison.
4) Increase & improve economic activity - Citizens returning to the community after incarceration will be employed.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties

for failing to meet deliverables or performance measures provided for the contract?

If the Contractor fails to meet respective performance standards, the department will impose financial consequences ranging from \$100-150, per participant who causes the deficiency. The department will assess financial consequences as a percentage of the fiscal year contract value, when compliance performance scores are less than 80% with additional consequences for repeat deficiencies.
