

1. Project Title Affordable Housing for At-Risk/Foster Children and Seniors - Hillsborough

4. Project/Program Description

New Life Village (NLV)'s Development Phase II expands its current housing project on its 12 acre campus. This is a construction project to build two residential buildings to house larger sibling groups of families affected by foster care. Kinship and foster-adoptive families live at NLV removing children from foster care or preventing them from entering the system. Residents are primarily low-income and most have been affected by multiple traumas. The two new buildings will comprise a total of 16 units with 12 3-bedroom units and four 4-bedroom units. New residents will have access to onsite holistic and therapeutic wrap-around services through NLV's program with a full program staff. This program aims to prevent the negative outcomes associated with foster care. A segment of NLV's population is seniors who have dedicated their retirement to supporting these families, offering an additional layer of support to the families.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

This funding will prevent or remove children from foster care and support Family First Act initiatives to place children removed from the home with kin or with permanent placements. It will also grant these at-risk youth on-site access to wellness services to mitigate the effects of trauma in a holistic and therapeutic environment. The negative outcomes associated with foster care include things like lower graduation rates, higher unemployment rates, and increased likelihood for homelessness. The 16 units house approximately 60 children and an estimated 20 caregivers.

b. What activities and services will be provided to meet the intended purpose of these funds?

NLV has completed a preliminary survey, construction plans are finalized, and pre-development work is complete. NLV has completed a competitive bidding process to ensure that the best quality contractor with the best priced quote will be used for the project. A development team with a construction background is in place to oversee the execution of this project with NLV. NLV has secured \$1,736,820 in HOME funding from Hillsborough County affordable housing for this development project and has raised \$1,327,950 in private funding.

c. What direct services will be provided to citizens by the appropriation project?

NLV's mission-based housing targets the vulnerable populations of at-risk youth affected by trauma/foster care. Residents have access to on-site services through New Life Village's Wellness, Resiliency, and Character Development Program. This program is designed to create daily connections and promote healing of trauma and family stability through access to services like after school tutoring, art therapy, sports mentoring, resource referrals, and more. This holistic program ensures that each child has a family that is supportive and supported. The village creates constant opportunities for all residents to build healing and trusting relationships with each other. NLV lives the proverb "it takes a village to raise a child."

d. Who is the target population served by this project? How many individuals are expected to be served?



This project will serve approximately 80 new residents (in addition to the existing 105 residents), consisting primarily of at-risk youth who have either been prevented from entering or have been removed from the foster care system. The new units will be geared towards larger sibling groups affected by foster care who have a harder time finding placement because adoptive families don't have access to affordable housing that is large enough. Other populations served by this mission are low-income seniors.

These families will live in an intentional-neighboring system that pairs each family with at least one dedicated senior who is there to support them in their needs. These seniors have dedicated their retirement to support these families and serve as surrogate grandparents, tutors, babysitters, etc., in order to strengthen the sense of family in the community.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Aside from the basic issue of affordable housing, this project will help positively impact the foster care crisis currently affecting the Tampa Bay community. Hillsborough and Pinellas counties lead the entire state as far as children being removed from the home. This model of intentional neighboring has the potential for replication in Florida. The outcome for this project will be measured by the number of families being brought to permanency (children prevented from entering/removed from foster care) as well as the outcomes achieved by their participation in the onsite Wellness, Resiliency, and Character Development Program like grade improvement, resource referrals, and other program participation metrics.

participation metrics. This model supports state initiatives for kinship placement and the wrap-around services are designed to mitigate the affects of trauma and foster care that can lead to negative outcomes like incarceration, drug abuse, teen pregnancy, and their children entering foster care.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

New Life Village will adhere to standard penalties and additionally will return any monies received.

A non-profit entity owns the land outright and mortgage-free. Approximately 9 acres of the New Life Village campus are undeveloped. The undeveloped portion of the land is pad-ready with electric, water, and sewage components already installed by a previous developer.
