#### 12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The City of Pahokee has experienced severe flooding throughout the City during rainy events. The City's storm water system in most areas is in critical condition and is completely inadequate to handle the level of storm water drainage today. Funding will address the storm water infrastructure issues on East Main Street including the sidewalks deterioration and provide for proper drainage to citizens and businesses in the area.

b. What activities and services will be provided to meet the intended purpose of these funds?

Storm water surges into local businesses and residential areas will be significantly reduced and controlled during rainy season, and during severe weather occurrences such as tropical storms and hurricanes. In addition, the main street corridor is the economic lifeline for the downtown area for this community and city. The proposed plans to renovate other amenities and mix-use space for which future exploration for business development will be possible if acceptable storm water prevention measures could be restored to modern codes and operation.

c. What direct services will be provided to citizens by the appropriation project?

Stormwater improvements and pollutant control systems to reduce pollutants discharging from street runoff into waterways, as well as reduce flooding on private properties and City streets and walkways.

d. Who is the target population served by this project? How many individuals are expected to be served?

7000+ City residents and visitors.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Improved stormwater management. Comparing the before and after results of access to traffic, decrease street and sidewalk flooding. Physical observation of water being retained in structures or swales for longer periods before running off into adjacent drainage ducts, and observation of less frequent flooding in roadways and walkways.
