#### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

Funding will restore Palm Beach's 1927 historic fire station to a safe and functional condition, allow for the continuation of fire and EMS response for the community, harden the building from the effects of future storms, and preserve the historic landmark nature of the building. The fire station will house fire rescue staff (EMS and Fire fighters) allowing for the delivery of emergency services for approximately 1/3 of the community on a 24/7/365 basis. The historic fire station has suffered from prior hurricane damage and worsening structural and water intrusion problems that have created an unsafe environment for the fire fighters.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The funding will contribute toward the cost of engineering and construction/renovation costs necessary to restore the historic fire station to a safe and functional condition, thus allowing for the continuation of fire and EMS response for the community. It will also provide for hardening of the building from the effects of future storms, and preserve the historic landmark nature of the building.

#### c. What direct services will be provided to citizens by the appropriation project?

The Town's 1927 historic fire station houses fire rescue staff (EMS and Fire Fighters) that deliver emergency services to approximately 1/3 of the community on a 24/7/365 basis. Renovation of the fire station will restore the building to a safe and functional condition, allowing for continued fire and EMS response for the community, harden the building from the effects of future storms thus preserving emergency response capabilities during storms, and preserve the historic landmark nature of the building.

### d. Who is the target population served by this project? How many individuals are expected to be served?

The Town of Palm Beach has a full-time population of approximately 10,000 residents. That number swells to approximately 45,000 seasonal residents, visitors, and people providing businesses and services.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

This project will allow for continued quick and effective fire and EMS response to the community from the North Fire Station, even during and after severe storms. The fire engine and rescue truck assigned to the North Fire Station had a combined 1103 emergency responses in the 2020-2021 fiscal year, with an average response time from call receipt to arrival at scene of 5.32 minutes. It is expected that the renovation of this fire station will allow the Town of Palm Beach to continue this excellent service delivery.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The Town of Palm Beach would impose liquidated damages comparable to the amounts included under Section 337.18, F.S.
