In FY 2020-21, the Faulk Center for Counseling received Paycheck Protection Program loans totaling \$257,655. This loan was used to off set the costs of existing payroll expenses.

Salary and Benefits	The Center employees 3 full-time licensed psychologists, at a cost of \$336,773, to oversee, manage, and evaluate the clinical services being provided through our APA approved internship program (4 doctoral interns),our practicum program (27 graduate and doctoral students), and metal health professional volunteers. The on site clinicians ensure the quality and delivery of mental health services. Requested funds will be used to offset this cost.	70,000

Each academic year, the Center takes on 4 doctoral interns, at a cost of \$80,000, to provide direct clinical mental health services. Interns come from accredited universities and are rigorously vetted and regularly evaluated by on site licensed clinicians to ensure that the quality of services meets or exceeds the services you would get from a licensed psychologist. 12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The APA has found that economically disadvantaged, racial/ethnic, gender, and sexual minorities suffer from poor mental health outcomes at higher-levels due to inaccessibility of mental health care services, cultural stigma surrounding mental health care, discrimination, and overall lack of awareness. With a primary focus on low-income children, adults, seniors, and families, the Center serves those with the highest need. We provide personalized treatment for a variety of mental health issues with the goal of improving the emotional, psychological, and social well-being of individuals, couples and families.

b. What activities and services will be provided to meet the intended purpose of these funds?

Clients who receive counseling services are provided a treatment plan based on their individual needs and approved therapies identified in the Diagnostic & Statistical Manual of Mental Disorders. Progress is measured based on improvements from baseline assessments of symptomatic and functional impacts, identified during the initial intake and early sessions. Issues being treated are often the result of many underlying and intertwined dynamics. Clinicians are aware of this and are trained to adjust their approach, strategies, and timeline for progress to match that of the issues being presented by the client.

c. What direct services will be provided to citizens by the appropriation project?

Clients work one-on-one with a mental health clinician in a safe, caring, and confidential environment. Individuals are provided the opportunity to freely explore their feelings, beliefs, and behaviors so they can identify and work through aspects of their lives where change is desired. Weekly group counseling and support groups provide opportunities to reduce isolation, receive peer support, and collectively heal. Services to vulnerable populations, including seniors and children, are targeted through on site programs. Regular education and outreach events supplement the care of those who utilize our services.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population for counseling services is low-income, no-income clients who reside in Palm Beach County and/or North Broward County. The Center provides service to over 2,000 individuals each year. State funding will allow us to provide reduced/no-cost services to 500 individuals who financially qualify. Services rates are already very accessible starting at 1/2 the cost of comparable services. Reduced rates are offered for individuals with a family income between 120-400% of the federal poverty levels (on a sliding scale). No-cost services are offered to those with a family income less than 120% of the federal poverty level.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Progress is measured by the reduction or leveling off of symptomatic impacts (e.g. depression, anxiety) and increases in self-esteem, self-worth and/or functional improvements such as better self-care, control of negative/disrupting behaviors, or increased engagement in community, home, school and/or work life. The following outcome will be tracked for this funding: 75% of 500 clients will demonstrate decreased symptomatic impacts OR increased functionality (engagement/social skills/behavior control/etc.) over a period of 12 weeks as measured by clinical notes, clinical observation and client feedback.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Since 1973, the Faulk Center has provided low-cost, no-cost psychological and mental health services to low-income individuals and families who otherwise would be unable to afford services. Our ability to effectively provide these services without interruption has allowed us to establish a reputation that is beyond reproach. We are confident that we will meet the stated outcomes. Penalties for not meeting contracted deliverables may warrant decreased funding.
