#### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

The Florida Center for Nursing was directed by the Florida legislature in FS464.0195 and FS464.0196 as follows:

Survey nursing employers regarding nursing workforce issues and submit a report by a designated date. Survey educational institutions regarding issues related to admissions, retention, graduation and other pertinent issues. Gather and analyze data regarding the supply and demand issues in nursing. Recognize programs of excellence that support a healthy work environment to retain nurses. Convene stakeholders to collaborate on solutions to the projected nursing shortage. (Including the impact of COVID-19 on the nursing shortage.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Contracting with experts, researchers, data analysts and professionals who can formulate surveys, analyze data and create reports that outline the current status and make projections of future need in order to enable a safe care environment for Florida's Citizens. Create a reporting mechanism to inform stakeholders regarding the status of the current nursing workforce in Florida.

#### c. What direct services will be provided to citizens by the appropriation project?



Access to current information and data regarding nursing workforce in Florida by way of a state of the art website with downloadable forms, strategies to address issues surrounding nursing workforce supply and demand. Information that can be used for planning and supporting various initiatives in the realm of healthcare including institutions, employers, healthcare providers, associated businesses (e.g. insurance).

Opportunities for leaders to convene to seek solutions to workforce problems such as the nursing shortage,.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Legislators and other policy makers, the healthcare industry, which includes, healthcare institutions, healthcare leaders educational institutions, educators, current students, and potential nursing students. It is also open to the public who can benefit by the information as partners and stakeholders in a healthy nursing workforce.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

The expected benefit is to have the information needed to address the projected shortfall in the nursing workforce which has been exacerbated by the COVID-19 pandemic. One way the outcome is measured is by the collection and reporting on the data which is available to leaders and stakeholders who can address the magnitude of the problem. The Center also creates a Strategic Plan which is one of the major deliverables that offers solutions to the issues reported by The Center..

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The current penalties are sufficient. The ultimate penalty is to reward the contract to a different entity, however there should be opportunity for correction and appeal particularly in the case of unusual or extenuating circumstances such as COVID-19 or other emergencies or disasters.
