### If yes, indicate the amount of funds received and what the funds were used for.

Yes - GEDI has received \$4.5M from the CARES Act from Hillsborough County. These funds were used to stand up the temporary GEDI facility for the immediate need for additional beds and space for COVID-19 patients. In total, TGH has received \$51.6M in CARES Act funding to help mitigate the total losses of -\$144M from March 2020 through January 2021 which was incurred as a direct result of the COVID-19 pandemic.

### 12. Program Performance

### a. What specific purpose or goal will be achieved by the funds requested?

These dollars are non-recurring capital expenditures associated with renovating the 1982 building and constructing dedicated ID inpatient units, education area, accommodations for the slew of ongoing USF ID research studies, pharmacy, lab, infusion center, telemedicine space, travel medicine and an outpatient ID clinic. Construction costs for the top two floors will upgrade the space into private, universal inpatient beds. It also includes building infrastructure and electrical updates within the GEDI. Additionally, the request includes clinical engineering and IT equipment throughout the building.

### b. What activities and services will be provided to meet the intended purpose of these funds?

These funds will allow TGH to develop a permanent Global Emerging Diseases Institute (GEDI) on its campus which will provide infectious disease treatment, research and education to citizens in Hillsborough County, the Tampa Bay region, and the entire state of Florida.

### c. What direct services will be provided to citizens by the appropriation project?

Since the temporary GEDI space was opened on October 27, 2020, 3,300 patients have been treated and discharged for a COVID-19 related admission. These requested funds will allow GEDI to expand outpatient care to include Sepsis follow-up care, HIV services, testing and treatment for COVID long-haulers and infusion services. It will also include cutting edge research and clinical trials.

d. Who is the target population served by this project? How many individuals are expected to be served?

According to public claims data, in Hillsborough County alone there are over 20,000 infectious disease outpatient followup visits annually. Since the capability to see infectious disease patients in an outpatient setting does not currently exist at Tampa General or other health systems in the region, that burden is transferred to the Department of Health and private providers. In addition to the local benefit, GEDI will serve as a support structure for all Floridians affected by infectious diseases as no such center exists in the state today.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

A cornerstone of GEDI will be the treatment of COVID long-haulers, an ailment that is estimated to affect anywhere from 5% to 7% that contract the virus. After acute infection, symptoms of the virus persist for weeks or months, and include shortness of breath, fatigue, brain fog, depression and more. Sepsis, also an infectious disease, is the leading cause of death in hospitals around the nation and will be at the forefront of GEDI efforts, post pandemic. Leading disease states as the most expensive condition to treat, sepsis contributes \$38.2 billion in healthcare costs annually and \$6.7 billion in Medicaid alone.
