Design and construction of a central sanitary sewer system, thereby eliminating septic tanks, will protect the general public (residents in this area specifically) from the significant health risks associated with septic tanks.

The 253 residential properties within the US 41/Goodlette Road corridor located within unincorporated Collier County but within the City of Naples water and sewer service area.

Reduction of nutrients in the water quality of the stormwater runoff to Naples Bay. Water quality samples will be collected before and after construction of the sanitary sewer system.

All contracts have performance requirements and penalties that protect the state's and the public's investment. No additional penalties are needed for this project.
