#### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

The goal of this project is to remove sources of bacteria and nutrients from the Estero River and Estero Bay watersheds to improve their water quality. The ultimate goal is to eliminate enough bacteria and nutrient sources so the Estero River and Estero Bay are no longer identified as impaired by FDEP. The Estero Bay is a State Aquatic Preserve and the Estero River sources is an Outstanding Florida Waters.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The project will remove three potential sources of nutrients and bacteria from the Estero River and Estero Bay watersheds.

#### c. What direct services will be provided to citizens by the appropriation project?

Removing potential sources of bacteria and nutrients will improve the Estero River and Estero Bay water quality. This will improve the recreational opportunities in both water bodies. It will also, help preserve both for future generations.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

That target population is all Estero and Lee County residents. Improved water quality will improve recreational opportunities, increase property values, and increase tourism.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected outcome is improved water quality in the Estero River and Estero Bay. The project will eliminate three sources of pollution from the Estero River watershed.

The Village of Estero proposes to include liquidated damages in the project's construction contract.
