The goal of this project would be to improve the roadways, drainage, and flooding in and around the city hall area of Madeira Beach.

b. What activities and services will be provided to meet the intended purpose of these funds?

This project will improve safety, existing drainage, and help with roadway flooding by installing tide flex valves.

c. What direct services will be provided to citizens by the appropriation project?

Safer roadways and improved mobility and drainage.

d. Who is the target population served by this project? How many individuals are expected to be served?

Approximately 4,000 full time residents, businesses, and tourists visiting the beach.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected benefit of this project is to have improved roadways. The storm water collection system will be evaluated and repaired as necessary. The replaced curbs will enhance the storm water collection in the immediate area. Once the project is completed it will be compared to the pavement condition report completed in 2018.

Madeira Beach will meet all requirements specified in the contract. If an issue is anticipated, the city will notify the Department of Transportation in advance and make any necessary adjustments.
