Decrease gang related activity among at-risk youth, Lowering crime, while also providing individual and group counseling, crisis intervention counseling, college preparatory and skills training, social skills training, along with recreational and diversion services.

Jobless Persons; Economically disadvantaged persons; At-risk youth; Homeless; Children of Veterans; Preschool students; Grade school students; High school students; and Victims of Crime. This projects aims to serve between 51 and 100 individuals.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Improve quality of education: Jax Gents will increase quality of in-and after-school literacy and mentorship programs, access to individual mentors and services for at-risk youth. Jax Gents will prepare a monthly report to the Dept of Juvenile Justice and Dept of Education regarding after school reading program, summer reading efforts and student achievements.

Reduce substance abuse: Jax Gents will focus on reducing and eliminating the use of illegal drugs by at-risk youth in Duval County.

Jax Gents agrees to repay 10% of the awarded funds back to the proper state agency. Jax Gents will report and develop techniques with the Dept of Juvenile Justice to ensure a reduce in substance abuse activity among youth in program.
