Park Place is seeking to add a full time Psychiatrist to work with both children and adults to serve our current and expanded caseload. Located in Osceola County, individuals whose primary language at home is Spanish make up the majority of our population (nearly 65%) and another one-third of those we serve are children. We are seeking 65% of salary support to add an additional psychiatrist to work with those who are indigent and uninsured, and to aid in provision of supervision.

It takes nearly a year for credentialing to be completed and sustainable case loads to be built.

Park Place will utilize the funds to support half of the salary of a bi-lingual psychiatrist to provide psychiatric evaluation and medication management for individuals who have limited access to care because they are uninsured and have limited financial resources.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Park Place will hire/contract with a bi-lingual psychiatrist to provide psychiatric evaluation, psychiatric medication management, and general health monitoring for those in need of services.

#### c. What direct services will be provided to citizens by the appropriation project?

The psychiatrist will provide psychiatric evaluation, psychiatric medication management, and general health monitoring for those in need of services.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Individuals in need of psychiatric evaluation and medication support to manage mental health and substance use disorder symptoms, who face barriers to care such as lack of insurance and sufficient financial resources, and language.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?



Fifty percent of the case load followed by this individual will be uninsured and lack the financial resources to seek care without support.
