**4. Project/Program Description**

The project involves looping three (3) dead end water lines in the eastern portion of the City. Water Line #1-Conventional Install 200 linear feet and directionally drill an additional 3,800 linear feet of 6" PVC water main along the east side of US Hwy 1 between County Road 108 on the north and Eastwood Road on the south, connecting into the existing 6" water main on the south side of the intersection of Eastwood Road and US Hwy 1, Water Line #2 - conventionally install 4,600 linear feet and directionally drill an additional 200 linear feet of 6" PVC water main beginning at the Eastwood Oaks Apartments on Eastwood Road continuing northerly along the east side of Eastwood Road until the water line connects into the existing 6" water main on the north side of CR 108. Water Line #3-Conventional Install 10,000 linear feet of 6" water main from American Legion Post 401 on Henry Smith Road connect into existing 6" water main on the East side of CR108.
