4. Project/Program Description

Completion of the final building phase for an affordable housing community featuring 76 single-family homes with park and green space. State funding will cover the hard costs of land development, construction, supplies, and contractors needed to build the remaining 38 homes. The funds will directly help build homes and create homeownership opportunities for 38 working families that cannot afford the median priced home in Broward and fall within 60-80% of area median income.

As this project is entering Phase III, support has been documented and well-received since breaking ground in 2017. Parties that have demonstrated support include, but are not limited to, Governor Ron DeSantis, Dr. Ben Carson, U.S. Senator George LeMieux, State Representative Chip LaMarca, City of Pompano Beach, neighboring church congregation, local leaders, and funding sponsors.

a. What specific purpose or goal will be achieved by the funds requested?

Providing affordable homeownership for 76 low to moderate income families.

b. What activities and services will be provided to meet the intended purpose of these funds?

Completion of the final building phase of three phases, for an affordable housing community featuring 76 single-family homes with park and green space. Funding would be used for shovel ready final stage for hard construction costs.

c. What direct services will be provided to citizens by the appropriation project?

Providing affordable homeownership for 76 low to moderate income families (between 350-400 citizens).

d. Who is the target population served by this project? How many individuals are expected to be served?

Between 350 to 400 direct individuals will be served by this project. Elderly persons, economically disadvantaged persons, at-risk youth, developmentally disabled persons, physically disabled persons, veterans, first-time homeowners, single parent households, preschool students, grade school students, high school students, victims of crime, and working families.

Habitat Broward builds strength, stability, and self-reliance through shelter. Economic self-sufficiency is made possible by providing affordable homes for families whose income can support the mortgage, taxes, and interest. Homeownership is an investment in their future that leads to less dependency and more stability. The net worth of homeowners is more than 44 times greater than that of renters.

This outcome is measured by pre and post surveys conducted before the homeowners enter the program and over time following their move into the home. As well, Habitat for Humanity International has various tracking methods for monitoring physical health improvements for families that have benefited from Habitat's programs. A study partnership with FIU is providing metrics as well.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Standard contract penalties are sufficient.

The land owner is Habitat for Humanity of Broward. Habitat closes on the property when it turns the land over to the new homeowner purchasing the home, and then Habitat becomes the mortgage holder.
