a. What specific purpose or goal will be achieved by the funds requested?

To provide scholarships for students, who exemplify Ari's unique light and characteristics, and who demonstrate financial need after exhausting all other funding resources, so that they may attend private high schools with an emphasis on a Christian education; provide financial support beyond high-school and into higher education; and provide assistance to these students (and their families) should they experience an unforeseen event or hardship.

b. What activities and services will be provided to meet the intended purpose of these funds?

The Foundation will provide 50 scholarships in the amount of \$5,000 each to students who demonstrate financial need and or medical hardship that has negatively impacted the family's financial situation. They must also achieve high academic standards and complete community service coordinated by the Foundation.

c. What direct services will be provided to citizens by the appropriation project?

The Ari Arteaga Foundation provides scholarships for students who demonstrate financial need so that they may attend private high schools with an emphasis on a Christian/Catholic education. Builds student leaders through its BE THE LIGHT Clubs in seven private high schools. It organizes community service activities that helps students serve other less fortunate members in the community.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is high school students. 25-50 students are expected to be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Students are required to apply for all available financial aid prior to applying to the Foundation for funding assistance. They must also maintain a 3.0 average, have good conduct, and not have missed more than four days of school in any academic year. They must provide two letters of recommendations, proof of their community service hours and extracurricular activities, and a personal essay.

The school must verify that the student has achieved a minimum GPA of 3.0., has good conduct, completed their community service hours, participated in extracurricular activities, and not missed more than four days of school. If in the senior year, the school must also report what university the student will be attending upon graduation. The school works closely with the Foundation to monitor the progress and successes of the student.
