The Florida Housing Finance Corporation initially provided the City of Clearwater with \$634,546 in CARES Act funding for mortgage, rent, and housing assistance. The city expended the entire amount and requested an additional \$400,000 to fund remaining unfunded requests for assistance prior to the expenditure deadline. The city was able to expend \$279,814 of the additional funds within the restricted timeframe and returned \$120,186 to the state.

Solar panels are to be installed on building roofs to support the city's mission of supporting green energy sources.

The appropriation project will not provide a direct service to citizens. Once the redevelopment of the entire waterfront park is completed, the Imagine Clearwater project will provide residents and visitors with additional greenspace, a bluff walk, new restrooms and a dockmaster building, and an improved connection to the downtown area.

The project will benefit no specific group. The enhanced waterfront park will be accessible to residents and visitors. More than 800 individuals are expected to be served.
