The purpose of this funding request is for funds to design and construct the new Calhoun County Administration Building/County Extension Office for the Calhoun County Board of County Commissioners and the citizens of Calhoun County. #### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

The goal of the funds being requested is to design and construct a new Calhoun County Administration Building/County Extension Office for the Calhoun County Board of County Commissioners. The staff currently operate out of the basement of the Calhoun County Courthouse, and the County Extension Office staff currently work out of a building across the street. The new building would create a more spacious and efficient work environment for these employees and allow county staff to access their offices without having go through the courthouse.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

These funds will allow for the design and construction of the new Calhoun County Administration Building/County Extension Office. This will also provide better access for the Calhoun County employees and citizens to conduct business with the county administrative staff.

#### c. What direct services will be provided to citizens by the appropriation project?

Citizens will be provided with more convenient access to the Calhoun County administration staff of housing, building inspection, grant administration, facilities operations, and the County Extension Office staff. Offices will be more conveniently located and accessible than they are now in the Calhoun County Courthouse basement and Extension Office building.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population of this project is the entire Calhoun County population. Employees will be there on a daily basis, and all citizens will have access to the county administrative staff. Approximately 15,000 individuals.

#### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

Convenience for all Calhoun County citizens and employees.
