a. What specific purpose or goal will be achieved by the funds requested?

R4W-H supports the State of Florida's strategies to reduce incarceration costs and to reduce Florida's prison population in order to sustain cost reductions. R4W-H's goal is to generate returns on investment not only by reducing recidivism but also by reducing crime and breaking cycles of hopelessness. R4W-H's approach through comprehensive reentry services and employment reduces crime, provides job and economic development, and helps to foster self-sufficient members of society.

b. What activities and services will be provided to meet the intended purpose of these funds?

Per existing proviso Specific Appropriation 721, these funds will provide a pre-release needs assessment, a plan-of-care, and referrals for incarcerated participants. Ready4Work-Hillsborough will primarily provide post-release services including assistance with transitional housing, case management, professional development and essential life skills training, family reunification/support, and job placement assistance. These non-recurring funds will also provide funding for basic computer literacy training which provides essential skills that are critical in today's society and workplace.

c. What direct services will be provided to citizens by the appropriation project?

Per existing proviso Specific Appropriation 721, these funds will provide a pre-release needs assessment, a plan-of-care, and referrals for incarcerated participants. Ready4Work-Hillsborough will primarily provide post-release services including assistance with transitional housing, case management, professional development and essential life skills training, family reunification/support, and job placement assistance.

Offenders under Department of Corrections' community supervision and formerly incarcerated inmates (no more than three (3) years post-release) returning to Hillsborough, Pinellas, Pasco, or Polk counties. We expect to serve 100-150 people.

- e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?
- 1) Improve physical & mental health Participants will attain pubic healthcare coverage or through their employer; and receive a mental health assessment.
- 2) Reduce Substance Abuse Participant will receive a substance abuse assessment.
- 3) Protect the general public from harm, Divert from Criminal/Juvenile Justice System, & Reduce Recidivism- Formerly incarcerated citizens that are engaged, employed, and empowered are less likely to commit crimes and return to prison.
- 4) Increase & improve economic viability Citizens returning to the community after incarceration will be employed.
- 5) Enhance specific individual's economic self sufficiency Participants will receive essential life management, employability, and financial literacy training. Participants also receive employment placement assistance.
- *All outcomes are documented in the program's Efforts-to-Outcomes data system, tracked by the Case Manager, and reported to the Department of Corrections monthly and quart
- f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The Department will impose financial consequences per participant for performance measures such as client services and client milestones not met per the contract. Additional financial consequences will be assessed as percentages of the fiscal year contract value based on timely invoice submissions and evaluation ratings specified per the contract.
