4. Project/Program Description

Funding will assist the City of Sarasota in completing a critical downtown segment of the 19.6 mile multi-use trail extending from Venice to Sarasota. In November 2018, county voters approved a bond referendum to extend the Legacy Trail north along the existing rail corridor to Payne Park in downtown Sarasota. This extension is near completion and the city is pursuing funds to provide public safety measures including signage and markings on School Ave.; bike connection on East Ave. south of Payne Park; multi-use path along S. Payne Pkwy right-of-way and bike connection over Alderman MURT; multi-use path on School Ave. right-of-way between Main St. and Ringling Blvd.; and complete street project on Ringling Blvd. from Lime Ave. to Paul Thorpe Park.

In total the city will receive \$10,123,762 of COVID-19 related (American Rescue Plan Act) assistance from the federal government. \$5,061,881 was received in April 2021 and the second half will be received in April 2022. The first tranche of funds will be allocated towards implementing broadband infrastructure in city parks (\$876,446) and replace lost city revenue (\$4,185,435).

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Funding will assist the City of Sarasota in completing a critical downtown segment of the 19.6 mile multi-use trail extending from Venice to Sarasota. In November 2018, over 70% of Sarasota County voters approved a bond referendum to extend the Legacy Trail north along the existing rail corridor to Payne Park in downtown Sarasota. This extension is near completion and the city is pursuing funds to provide public safety measures including signage, a complete street project, and an additional multi-use path.

b. What activities and services will be provided to meet the intended purpose of these funds?

10,560 feet of multi-use trail for resident, visitors, and employees to connect into the downtown urban core of Sarasota and improve multi-modal connectivity.

c. What direct services will be provided to citizens by the appropriation project?

10,560 feet of multi-use trail for resident, visitors, and employees to connect into the downtown urban core of Sarasota.

d. Who is the target population served by this project? How many individuals are expected to be served?

Based on the existing usage of the Legacy Trail, the city estimates over 200,000 annual users of all ages and demographics will utilize the trail extension segment.



e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Increased physical and mental health measured through annual user surveys and statistical analysis. Increased economic activity of businesses within 2 miles of trail as measured through surveys and/or available business data. Improve cultural and historical experiences along the trail through increased number of signage. Increased transportation conditions by measuring number of commuters using trail to get to work as measured through annual user surveys and statistical analysis.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Time limit on submitting applications in the future. Return of funding.
