General operational costs such as permitting and inspection fees are likely to be incurred. Construction/Renovation/Land/ Planning Engineering	Extension of the sewer line along Curley Street to Pasco Road would encompass approximately 2600 linear feet. Materials would involve the extended force main, components such as manholes, valves, and cleanouts, and lift stations as required. Costs associated with the service extension to City Hall/Fire Station would include materials and removal of the existing septic tank. Additional costs would include replacement of sod/asphalt disturbed during construction.	850,000

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Funds will be used to encourage property owners within incorporated San Antonio to migrate from septic tanks as their means of waste water disposal in favor of sewer connections maintained by Pasco County. Extending sewer service to the City Hall and Fire Station would eliminate the need for a shared septic tank between the systems, and generate a more centralized area of sewer service in the downtown area.

b. What activities and services will be provided to meet the intended purpose of these funds?

By extending the sewer line to the intersection of Pasco Road and Curley Street, a significant number of residential and commercial property owners would have the option to connect to the sewer utility at a decreased cost. Access to the extended line would be available to both existing properties, along with ones currently in development within the city. By connecting City Hall and the Fire Station on Pennsylvania Avenue, the shared septic tank for the two buildings would be able to be removed and disposed of. This connection would also tie the service area extending through the downtown area together, creating a more compact section of available service.

c. What direct services will be provided to citizens by the appropriation project?

Property owners interested and willing to connect to the Pasco County sewer utility would benefit by being allowed to remove septic tanks from their properties. This would also give connected owners the ability to report sewer service issues to Pasco County directly as opposed to having to assume maintenance burdens associated with septic tank maintenance. By extending the force mains, a wider amount of people would be able to connect to the service in a more cost effective manner, reducing the burden of cost for petitioning for the extension as individuals or as a smaller community organization.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is the general population of San Antonio residents living in areas outside of existing sewer line service areas along Curley Street south of 3rd Avenue.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Expected benefits would include more residential and commercial properties switching to a sewer service, measurable by coordination with Pasco County on new accounts being opened. Additional tracking would be done through coordination of permitting for additional line extensions to properties switching to sewer service.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Failure to meet deliverables as outlined in agreements between the city and other parties associated with the project will lead to penalties such as withholding of payments. Anticipated deadlines would be agreed upon prior to commencement of work on a project to ensure compliance, along with requirements to submit proof of progress throughout construction.

Sewer lines would remain the property of Pasco County Utilities, with the City of San Antonio retaining ownership of the right-of-ways and/or roads that lines may be installed near.
