**12. Program Performance**

**a. What specific purpose or goal will be achieved by the funds requested?**

This project's proposed improvements primarily consist of roadway and stormwater upgrades to address ponding and nuisance flooding and to better define the road cross section components. This project also proposes sidewalk and bike lanes for multimodal connectivity. The other potential major component of this project is water main upsizing to provide improved domestic and fire protection service in the project area.

**b. What activities and services will be provided to meet the intended purpose of these funds?**

Contracted activity and services under this funding include surveying, demolition, clearing, geotechnical services, design, permitting, cost estimating and construction of drainage, and landscape improvements.

**c. What direct services will be provided to citizens by the appropriation project?**

This is a much-needed public safety, landscape, and drainage improvement project as documented in several local meetings with support by residents and elected officials. The main services of this project include protecting the general public and providing safety and security to local residents by enhancing pedestrian access and sidewalks and by providing drainage and water quality improvements in case of storm events. This project will also improve accessibility, security, and crime protection by enhancing landscape lighting.

The target population of this project is are local residents, as well as other pedestrian and bicyclists from the city and neighboring areas and visitors that will benefit with the recreational and safety features of the project.

The expected benefits of this project are safety to pedestrians and bicyclists, drainage improvements as well as community awareness through a public education program. The methodology for this project includes structural as well as non-structural components to provide a comprehensive approach.
