The Baldwin's Stolen Saddle Ranch project is a passive water quality project in Sheep Pen Marsh. During high flow events, water can be diverted from Tiger Bay Slough using boards, culverts and ditch widening. Initial estimates demonstrate that the project can store and treat approximately 4,000 - 5,000 acre feet of water before it enters the Charlotte Harbor which is part of the Coastal and Heartland National Estuary Program. This project is designed to improve the downstream water quality by passively treating basin water that flows through the subject property during wet flow events and provide return flow to the receiving waters downstream during dry conditions . The PD&E Funds will be used by the SWFWMD to design a project consistent with their programs and goals.
