Engineering services will include the final design, permitting, and bidding services for the project. Finally, construction includes construction of new drainage system, pretreatment swale, and exfiltration trenches.

c. What direct services will be provided to citizens by the appropriation project?

Citizens will experience improved traffic conditions on NW 35th St. and NW 2nd Ave. during storm events. This project will reduce the number of accidents and flooded vehicles during rain events.

d. Who is the target population served by this project? How many individuals are expected to be served?

All those who travel on NW 35th St. and NW 2nd Ave.will be impacted by this project. About 20,000 AADT.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

One expected benefit and outcome of this project is a reduction of nutrients in surface water discharge as measured through the use of engineering standards for storm water removal and water treatment. This project will also reduce the number of accidents and flooded vehicles during rain events. Another expected benefit and outcome of this project is a reduction of roadway flooding.
