Funds will be used to design multi-use trail improvements including raised intersection tables and crosswalks to improve safety and increase pedestrian visibility; and lighting, landscape, and streetscape amenities, such as benches and trash receptacles.

Site analysis and programming to design facilities incorporating stormwater management practices, utilize sustainable materials, and provide universal accessibility recognizing mobility limitations to improve quality of life. Additional services include project management.

#### c. What direct services will be provided to citizens by the appropriation project?

The project will design new sidewalks, raised crosswalks and other related safety improvements to enhance walk-ability and safety. The project will also include other safety improvements such as lighting, bike lanes, and landscape improvements.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population include residents, visitors, and businesses located on Galt Ocean Drive, Fort Lauderdale, FL.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The project expected to prioritize the livability and walk-ability for pedestrians within the City, mitigate urban heat island effect, and enhance water quality and infiltration. The City will measure the reductions in energy and water use as well as benchmark the reduction in traffic accidents and increase in economic activity.
