### 4. Project/Program Description

Career Readiness and Workforce Training Program Expansion with a focus on culinary management, supply chain, logistics and CDL training. It was developed to assist the unemployed and underemployed acquire job readiness skills, certifications and credentials in order to meet workforce demands across diverse industries. The program will focus on training for veterans and will include funding for scholarships to cover the cost of training as well as work study funding to cover the cost of transportation, computers, certificate testing, books, and supplies. Funding will also cover Director of Job Training Programs, Program Administration, and a Job Training Counselor to help with student recruitment, case management, resume writing and job placement. Culinary Training Expansion – additional 12-week program to learn the food truck business can be done separately or after completing our original 12-week Culinary Training Program.

Students can earn the following credentials and certifications: ServSafe Managers' Certification, Certified Guest Service Professional, BH Barista One Certificate, Nutrition 2.0 Certification, Forklift and Pallet Jack Certification, CDL/Class A & B , Certificate of Materials Management.

### c. What direct services will be provided to citizens by the appropriation project?

Culinary Management, Barista, Hospitality, CDL, and Supply Chain Training.

### d. Who is the target population served by this project? How many individuals are expected to be served?

Jobless persons, economically disadvantaged persons, at-risk youth, formerly incarcarated persons. At full capacity, we can provide training to 376 students per year.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

### be measured?

Benefit: Improve Mental Health: Students will improve their self-esteem and gain more a positive outlook for future employment throughout the training programs. Pre and post program surveys to measure quality of life, self-esteem, and outlook on future employment. Benefit: Enhance Economic Self Sufficiency: Graduates will be able to open their own business and sell at the farmers' market, enroll in the Culinary Management Program at IRSC, gain employment in local kitchens, coffee shops, warehouses, distribution centers, and trucking companies. Will be measured by the number of graduates that are employed. So far the program has had 140 graduates obtain employment.
