14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

To run a statewide pilot of the Math Matrix program to improve the quality of mathematics teaching and learning. The Math Matrix is a comprehensive online, on-demand professional development system for teachers in grades K-12. The Math Matrix will offer engaging resources and evidence-based collaborative professional learning opportunities to improve student outcomes and expand future education and career opportunities for all learners. The pilot is designed for 250 teachers.

b. What activities and services will be provided to meet the intended purpose of these funds?

Florida teachers will receive training to improve their knowledge, skills, and abilities in mathematics instruction. Teacher recruitment activities. Teacher enrollment. Facilitating teacher's participation in the courses and provision of feedback. Teacher feedback will be collected and analyzed to improve the program. Pre and post assessments will be conducted and analyzed to demonstrate program effectiveness. A report on the results will be created and disseminated.

c. What direct services will be provided to citizens by the appropriation project?

Florida teachers will receive training to improve their knowledge, skills, and abilities in mathematics instruction. Florida students of participants will benefit from improved math instruction.

d. Who is the target population served by this project? How many individuals are expected to be served?

Primary target population: teachers, coaches and administrators involved in mathematics instruction in Florida K-12 public and charter schools. The pilot will enroll 250 participants. A fully implemented version would be provided to hundreds more each year. Additional target population: all Florida K-12 public and charter students will benefit from improved math instruction.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The FL DOE identified mathematics as a critical teacher shortage are for 2022-2023. By offering teacher training and professional development, the Math Matrix will help to address this shortage by equipping and retaining current teachers. Benefits will be measured by Teacher retention rates. Improved instruction will yield improved student outcomes. Improved instruction will be measured by teacher practicum outcomes, and evaluation of teacher knowledge pre and post program participation. Student outcomes will be measured by EOC and/or FAST student data.
